Standards for Contact Lenses

By updating its 2003 guidelines for contact lens use in industrial settings, the American College of Occupational and Environmental Medicine (ACOEM) intends to inform physicians in the workplace of OSHA standards regarding the use of this eyewear. Key among the points is that contact lenses do not fulfill PPE requirements for eye safety in the performance of eye-hazardous work tasks, although they do provide the best visual ergonomics for users of full-face respirator masks. Special training in first aid may be needed for contact lens wearers at risk for chemical exposure.
